Overview:




The workshop was a transformative experience, with a primary focus on


comprehensive toolkit to navigate complexities that may arise, ensuring they are well-prepared to address sensitive issues.




of KAMP is to identify and capture Scientific and Technological temperament students to make India а Global Leader in the fields of Science. technology, and the humanities.
